3.0 After discussions the following decisions were taken

A. Regarding website

In the 10th EC meeting convened on 13-2-2023 it was decided to create a web site for the association for higher visibility and convenience. Accordingly verified in the market and quotations have been taken. One quotation submitted by M/s Redminds Technology is found to be reasonable and their technical capabilities are also convincing. **Therefore approval has been given to create a website for the association through M/s Redminds Technology at a cost of Rs 41,300 including taxes.**

B. Withdrawal of money from the Bank and opening a new account in Union Bank of India Wilson Garden.

The association has a Bank account in M/s Apex Bank, Vidhana Soudha. Earlier the procedures were simple and the money could have been withdrawn from other branches also, more particularly from Wilson Garden branch. Now withdrawing money has become a long procedure. Also earlier the DPAR was issuing Entry pass to Vidhana soudha without much difficulty. Now they have asked for so many documents. Meanwhile it is found that transferring the money to some other account is relatively easier. Therefore it has been decided transfer the money to some personal account and withdraw cash to meet out the expenditure for the website. Further it has also been approved to open another current account in Union Bank of India and once the new account becomes operational we can close the account in Apex Bank.

C. Action taken regarding irregular postings for the Department of Printing and Stationery.

The posting to the post of Director Printing and stationery has been made by the Government flouting the C & R rules which was opposed by the association by submitting a letter to the secretary, Primary and Secondary education. The EC approved to pursue the matter to ensure that the law is upheld.

D. Action to be initiated for administrative reforms.

a) SOP for the Departments

To submit a letter to the Chief Secretary and request to formulate a departmental manual inclusive of Standard Operating Procedures for every Department so that errors by the officers will be reduced. This will also help to bring in efficiency in administration

b) C & R to be published for all departments and shall be practical

To amend and publish the C & R to all the departments at the earliest. Also to request the CS to make the C & R as practical as possible

c) BBMP issues



To request the administrator of BBMP to amend the building byelaws and make it more practical.

E. Prizes to children of the members

It was introduced the practice of giving prizes to the achievers of the children of the members in 10th, PUC, Engineering and Medical. For this purpose it was decided to issue a notice calling for the marks obtained by their children in the above courses in the academic year 2024-25. The top scorers will be rewarded. The number of prizes and the prize amount would be decided in the next meeting
